**\$9,000 for 45 cooks with a \$165/cook adjustment for more or fewer participants\***

This traditional three meat (half chicken, pork spare ribs, and beef brisket) contest is open to all competition cooks. Entrants will be given one brisket, two whole chickens, and two racks of ribs to cook in this contest. No other meat can be used.

**Registration Options:**

- BCA Member Registration Fee \$300  
The deadline for payment of the 2025 BCA cooking membership dues is midnight, Thursday, January 30, 2025. Each participant in this category must be at least a BCA "Yearly Cooking Member" (\$50/year in 2024).
- Non-BCA Member Registration Fee \$400  
Payment does not include BCA membership.

- BCA membership for 2025 must be current to get the \$300 rate for the contest.

**RV Spot and Cabin Information:**

- The contest is being held at the Poche's RV Park and Fish-N-Camp, which is located at 1080 Sawmill Highway in Breaux Bridge, LA. Poche's is offering RV spots for the contest at a discounted rate with full power, water, and sewer. They also have a small number of one, two, or three bedroom cabins available for rent at discounted rates.
- To make a reservation, call Poche's directly at (337) 332-0326 and mention you are cooking in the contest. Participants must reserve an RV spot or cabin to cook in the contest.

**Logistical Information:**

- BCA rules will be used in this contest (<http://www.bcabbq.org>).
- The cooks meeting will take place at 6:00 pm on Friday, January 31, 2025. The annual BCA awards ceremony, installation of new officers/board members, followed by a gumbo dinner will be held immediately following the cooks meeting at the same location.

\* For the basic formula, the number of paid places will increase or decrease with the number of paid entries down to a minimum of 30 participants. For example, a contest with 40 registered cooks will have a total payout of \$8,175. For contests with less than 30 cooks, the payout will be based on a different formula. For smaller contests, the payout will be \$2,800 for 15 cooks with an additional \$155/cook for 16-29 participants.
